OFFICIAL INFORMATION ACT REQUEST 2022/01

On 24 January 2022 you made a request under the Official Information Act 1982 (the Act) for the following information:

We request all correspondence between the Electoral Commission and the Ministry of Justice after 1 January 2021 regarding the current disclosure regime for loans and donations expressed in the Electoral Act 1993. We also request any assessments the Electoral Commission has made that indicate the financial implications of any changes to the current disclosure regime.
