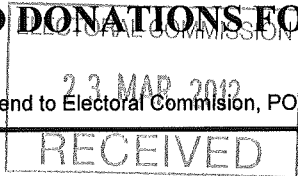

In the brief description, include identifying information on the advertising and publicity including date, volume, duration, content and size as appropriate.
